BID FORMS: All bids are to be submitted on a Bid Proposal form as prepared and furnished by the Township and must indicate the total quantities and prices for each item listed.

COMPLETION DATE: The Trustees require that this project be completed within 60 days after bid acceptance.

Contract: The contract will be awarded to the lowest and best bidder.

BID BOND GUARANTEE: In accordance with Section 153.54 of the Ohio Revised Code, each bid must be accompanied by a Bid Bond or a Bid Guarantee for 10% of the bid amount. The bidder to whom the contract is awarded will be required to furnish a Contract Bond for 100% of the contract price. All Bonds filed pursuant to this requirement shall be issued by a Surety Company or Corporation licensed in the State of Ohio to provide said surety.

PREVAILING WAGE: Bidders must comply with the prevailing wage rates for Public Improvements in Portage County and in the Township of Suffield as determined by the Ohio Department of Industrial Relations

Township Rights: The Township reserves the right to waive irregularities, to revise any and all quantities, to require that only part of the work be done and to reject any and all bids.

BID OPENING: Opening of the bids will be held at the Suffield Administrative Office Building on Tuesday, June 11, 2013 at 8:00PM.

The bids must be sealed and plainly marked "BID ENCLOSED".
