

The Suffield Township Board of Trustees met at the Administration Building on June 8, 2017 for the purpose of paying the bills of the Township Chairman. Chairman David Vartenuk called the meeting to order at 8:00 PM. Present were Board Members Thomas Calcei, Jeff Eldreth, David Vartenuk, and Township Fiscal Officer Lori Calcei.

LOCAL GOVERNMENT MONEY

Mr. Calcei informed us of a meeting that was held to discuss the Local Government Money that the County receives. Every 10 years the townships, villages, cities and county have to agree how the local government money that is given to Portage County by the State will be divided. Mr. Calcei will be Suffield Township's representative. This decision needs to be made by December 17, 2017.

ROAD DEPARTMENT REPORT

Mr. Eldreth informed us of the following:

1. The site distance problem on Swartz has been taken care of.
2. We are still mowing.
3. That we are putting road culverts in on Pontius from Duquette to Congress Lake Rd.
4. Portage Line cut and patch work has started from 224 to Tisen.

ZONING REPORT

Mr. Vartenuk informed us of the following:

1. The junk cars that were at the Copland property are gone but there is still trash there.
2. Mr. Vartenuk decided that we are going to put the Land Use Plan on hold. We will make a decision after August whether or not we move forward with it. The books have already been printed.

COMPLAINTS

1. A resident informed the Trustees that there is trash in front of 1131 SR 43.
2. A resident complained about 1257 Wingfoot. This property is owned by the State of Ohio. It was suggested that we contact Senator Ecklund about this property.
3. A resident complained about the intersection of Spring Valley Rd and Martin Rd. He stated that this intersection really needs mowed.
4. Mr. Calcei informed us of a complaint from a resident who lives on Randolph Rd. He is upset that his neighbor is cutting down trees. Mr. Calcei informed him that we could do nothing to stop a resident from cutting down trees on his Property.

MEETING

It was discussed and agreed upon that we will go into executive session at our next meeting held on June 27, 2017. This will be to discuss a legal matter and Tim Pero a Portage County Prosecutor will be in attendance.

BUDGET HEARING
